

## Lottery Terms and Conditions

1. These Terms and Conditions are the Lottery Rules. By entering the lottery, entrants agree to be bound by these rules.
2. Purchase of entries to the MUKTI Lottery must be from the Traditional Yoga Association® in accordance with the terms under which it promotes its lotteries.
3. Entries will not be sold to or by any person in a street, unless sold from a kiosk or on the doorstep by a representative of The Traditional Yoga Association® only.
4. Entrants must be residents of Great Britain (England, Scotland and Wales) and 18 years of age or over. Any person found to be under 18 years of age automatically forfeits the right to any prize. UK law states that no entries can be sold by a person under the age of 16.
5. Entrants must provide accurate and legible entry information, including name, personal address, telephone number and email address, and must inform The Traditional Yoga Association® of any changes to these details as soon as they arise and no later than 15<sup>th</sup> May 2016.
